This competition is conducted for the benefit of Little BIG Foundation Limited ABN 72 650 451 522, registered office being 16 Flour Mill Way, Summer Hill, NSW Australia 2130 ("Registered Office") telephone 02 9220 7005. By entering into the Competition, entrants accept these Terms and Conditions of Entry and warrant they have read, understood and agree to be bound by them.

Eligibility and Entry to Competition

1. Entry is open to tenants and employees of the following buildings:
 - a. 32 Walker Street, North Sydney, NSW
 - b. 50 Carrington Street, Sydney CBD, NSW
 - c. 95 North Quay, Brisbane, QLD
 - d. 2 Mill Street, Perth, WA

Draw and Method of Draw
